- 7. To examine all grievance letters received from the women staff / students regarding the sexual harassment.

- 9. To give feedback to the women staff / students concerned / to find solution for their grievances.
- 10. The committee will record such grievances received from the women staff / students, in a separate register maintained exclusively for this purpose. The reply given by the committee to the women staff / students for grievance should also be recorded in the register.
- 11. The Committee should find suitable solutions to settle the problems faced by the women staff / students in regard to matters relating to sexual harassment within 10 days' after thorough investigation.
